

Vulkon Dealers Contract

PRICES: Vendor prices are \$150 per table for every show. There will be no additional discount for multiple tables or early payments. All tables must be paid for in full at the time of reservation to hold your space.

BADGES & AUTOGRAPHS: Only TWO dealer badge per table ordered will be issued. Tables reservations do not include free autographs. Dealers desiring autographs may elect to buy autograph tickets at the Vulkon registration table.

REFUNDS: There will be no refunds or credits for cancellations less than 30 days prior to show (unless Vulkon can re-sell your table).

SPACE: You will not be able to extend your table space left or right, or beyond the front width of the table, whether the purpose is for display or for sales. Whenever possible, we will leave enough space to enable you to have narrow tables at the back; **TABLES MAY NOT BE PUSHED FORWARD.** If you need more space, please buy another table.

NOTE: Implicit in your participation at any Vulkon Convention event is your agreement to recognize **Paramount Pictures** as the sole copyright holder of the Star Trek properties. As such, vendors agree not to sell merchandise which is knowingly illegal, unlicensed, or otherwise not permitted by the copyright owner. Attorneys from **VIACOM** have served notice that the sale of any unlicensed merchandise at our event will be considered an infringement of Paramount's rights under applicable federal and state law, and Paramount will take action to enforce its rights.

EXCLUSIVITY RULE: Vulkon reserves the right to be the only source of Photos & Images* of the "Featured Guests" appearing at our events. Therefore you may not sell photos or images of the "Featured Guests". Vulkon reserves the right to confiscate un-approved literature and expel from the con those responsible for disseminating the flyers with no refund of their membership or table cost.

NOTICE: Vendors may not sublet any part of their assigned space, this contract is not transferable. No refunds on cancellations within 30 days of show date.
